- 1) The party No. 1 shall have access to party No. 2's sports field and surrounding facilities.
- 2) The Party No 1 shall ensure that all activities conducted on Party-2's grounds comply with the rules and regulations governing the use of the facilities and shall be responsible for any damages caused by its participants.
- 3) The Party No 2 shall provide its own equipment's, for the organizing events and matches respectively.
- 4) The Party No. 2 shall be responsible for maintaining the ground, including mowing the grass, marking the field boundaries and ensuring proper field condition for play.
- 5) The Party No. 1 and Party No. 2 agrees to maintain the confidentiality of any proprietary or confidential information disclosed during the course of this agreement.
- 6) The Party No.1 agrees to pay annual rent of Rs.10000 (Ten Thousand) to Party No.2.
- 7) This Agreement between two parties shall be valid from 2<sup>nd</sup> Feb.2023 upto 1<sup>st</sup> Feb.2026.

- 8) If any of the party wishes to discontinue this Agreement anytime during the agreed period then one month prior notice needs to be given to the other party.
