Minutes of the 3rd meeting of IQAC held on 8th January 2024

Welcome address was given by Principal Dr. D.S. Badwaik. Thereafter Dr. Smeetaa Wanjarri IQAC Coordinator read out the minutes of the meeting which was held on 4th October 2023 and confirmed the agenda.

2. Review of progress on AAA visit.

Adv. Abhijit Wanjarri, Management representative had conducted a thorough review of the preparations for the upcoming academic and administrative audit. He also provided crucial instructions to expedite the work, ensuring all compliance measures are met promptly. Staff were reminded of the importance of adhering to audit standards and completing tasks efficiently. Further Adv. Abhijit Wanjarri advised to construct the team committed to enhance coordination to meet the audit requirements on time.

3. Initiation of IIQA process

As the institution is underway of its fourth cycle of NAAC accreditation Principal Dr. D.S. Badwaik apprised about checking the readiness of Institution by proceeding to IIQA. To add further Dr. Smeetaa Wanjarri said that there should be collaborative efforts of all departments for the compilation and submission of institutional data. Since the IIQA process directly reflects the status and commitment of institution all the members agreed to proceed for necessary compliance at the earliest in ensuring a successful assessment and accreditation outcome.

4. Review of syllabus completion

The principal Dr. D.S. Badwaik conducted a detailed review on the current status of syllabus completion, identifying areas where progress was lagging. Emphasizing the importance of adhering to the academic calendar, the principal issued clear directives to faculty members to expedite their teaching schedules.

5. Review of upcoming international conference

A review was taken on upcoming International Conference on "Advanced Sustainable Futuristic Materials" ASFM 2024. Where Dr. W.B. Gurnule, convener of the conference informed that this conference is organised by Kamla Nehru Mahavidyalaya in association of Sharda University, Greater Noida and CSIR NEERI, Nagpur. Further he added that this conference has received funding from SERB and CSIR New Delhi.


6. Review of document as per criteria in every department


