4. Student Undertakings:


- All students and parents submitted anti-ragging undertakings via the online UGC portal during the admission process.

a. Awareness and Preventive Measures

- Anti-ragging posters and banners are displayed across the campus.

d. Help and Grievance Mechanism


- Contact details of ARC members are displayed on notice boards.
