Agenda No. 2: Discussion about conduction of online class and its report submission

Resolution No. 2:

The secretary informed that online classes commenced from march 2020 using platforms such as Zoom/Google Meet/Microsoft Teams/etc. Faculty feedback and student participation levels were discussed. Suggestion were given on submitting weekly/monthly reports from faculty member on the number of classes conducted, student attendance, and topics covered.
