Introduction

The Grievance Redressal Committee (GRC) of Kamla Nehru Mahavidyalaya, Nagpur, has been established to ensure a transparent, fair, and effective mechanism for addressing grievances of students and staff. The committee functions in accordance with the guidelines issued by the University Grants Commission (UGC) and the Government of India. The primary aim is to foster a secure and conducive academic and work environment by providing a systematic approach to resolving grievances.

Objectives

The objectives of the Grievance Redressal Committee are as follows:

- To establish a structured mechanism for resolving student and staff grievances.
- To ensure a fair and impartial resolution process.
- To maintain a democratic and student-friendly environment in the institution.
- To uphold the rights of individuals while fostering a culture of accountability and responsibility.
- To protect students and staff from any form of harassment, discrimination, or unfair treatment.

Composition of the Committee

The committee comprises the following members:

- **Chairperson:** Principal of the college
- **Members:** Senior faculty members representing different streams
- **Special Invitee:** A faculty member with relevant expertise

Term: The tenure of members and special invitees shall be for **one year**.
Quorum: The quorum for a meeting shall be **three members**, including the Chairperson but excluding special invitees.

Scope of Grievances

The committee addresses grievances in the following categories:

1. **Academic Matters:** Issues related to admission, teaching, evaluation, results, and certification.
2. **Financial Matters:** Complaints regarding fees, scholarships, and financial transactions.
3. **Library Issues:** Book availability, access to study materials, and other library-related concerns.
4. **Administrative Concerns:** Complaints regarding sanitation, hostel facilities, transportation, and other infrastructure-related matters.
5. **Harassment & Disciplinary Issues:** Cases of sexual harassment, ragging, or any form of mental or physical harassment.

Functions of the Committee

- To receive and scrutinize grievances submitted by students and staff.
- To conduct impartial inquiries and investigations into the complaints.
- To provide recommendations for resolution and ensure timely redressal.
- To escalate unresolved issues to the higher authorities if necessary.
- To maintain a grievance record and report periodically to the Internal Quality Assurance Cell (IQAC).
- To uphold confidentiality and prevent victimization of complainants.

Procedure for Lodging a Grievance

1. **Written Complaint:** Aggrieved individuals can submit a written complaint to the committee or drop it in the suggestion/complaint box.
2. **Email Submission:** Complaints can also be sent via email to the designated GRC officer.
3. **Confidentiality:** The complainant may choose to remain anonymous while submitting a grievance.
4. **Resolution Mechanism:** If required, the committee will summon both parties for discussion and mediation.

5. **Final Decision:** In unresolved cases, recommendations shall be forwarded to the Principal or higher authorities for final resolution.

Powers of the Committee

- To call upon individuals for discussions regarding the grievance.
- To seek additional evidence and conduct independent inquiries.
- To recommend disciplinary actions, which may include:
 - Verbal or written warnings
 - Parental notification (if applicable)
 - Financial penalties
 - Referral to law enforcement (if necessary)
 - Expulsion from the institution (in severe cases)

Monitoring and Review Mechanism

- The committee shall meet periodically to review grievance cases and their resolutions.
- A detailed report shall be maintained for internal audits and submitted to the IQAC.
- Feedback shall be collected to improve the grievance redressal system.

Conclusion

The Grievance Redressal Committee is dedicated to ensuring a fair and transparent process for addressing concerns. Students and staff are encouraged to use this platform to voice their grievances without fear of victimization. The institution remains committed to fostering a safe, respectful, and inclusive educational environment.

2. **Issues related to the college fees to economically background students:** Dr. Sucheta Parkar said that there is a request from few students about giving installments for paying college fees due to their financial condition. Principal Dr. D.S. Badwaik take up this issue and said that for fees grant, the issue has been considered for financially background students and further decisions can be made after discussing with administrative authority.
3. **Issues related to classroom cleanliness and sitting arrangement of students:** The discussion was held on cleanliness of class rooms and sitting arrangements for the students as rooms are not cleaned regularly by the housekeeping staff. Dr. K.A. Bhajani further said that furniture in the classroom is also not sufficient for students to sit.
