1.1 AGREEMENT

1.1.1 This agreement made and entered into on this 14/01/2016

Between **Parties** (hereafter called **Council** which expression shall where the context so admits include its successor and permits assigns) of the part.

1.1.2. The details of the party

SAI BIOSYSTEMS PRIVATE LIMITED: Party1

and

KAMLA NEHRU MAHAVIDYALAYA: Party2

1.1.3 **SAI BIOSYSTEMS PRIVATE LIMITED** in India under the name and having its headquarter at Raghujai Nagar, Nagpur (herein after called **Party 1** which expression shall where the context so admits includes its successor and permitted assigns) of the party.

1.2 PREAMBLE

1.2.1 Whereas the Party1 is engaged in training/ Research/Development and extension related work in the field of **Biotechnology/Bioinformatics/Life science/Statistics/Molecular Biology** and desirous of collaborative research with party 2 on **Microbiology/Biochemistry**.

1.2.2 Whereas **Party 2** is engaged in the fields of Microbiology, microorganism cultivation, species identification, analytical methods, biochemical characterizations and has agreed to provide facilities for undertaking research work in the field of Life Science as detailed in appendix I to the agreement (herein after called project) on the basis of collaborative agreement.



Now, therefore, in consideration of promises and mutual consent herein after content, the parties here to agree as follow,

1.3 Scope of the Agreement


- 1.3.1 The agreement detailed the terms and conditions, financial agreement, intellectual property rights, responsibility and obligation of collaborative party and council/institute pertaining to the project.
- 1.3.2 Both the parties hereby agree for the following terms and conditions in the implementation of the collaborative program/project/thesis work.
- a. The duration of the research assignment will be for the maximum period of six months in the respect of M. Sc. Program and two years for the Ph.D. programme.
 - b. The Party1 and party 2 will provide the laboratory and facilities for the conduct of research work leading to a B. Sc, M. Sc. or Ph. D degree provided the entire research work for the respective degree is carried out at Party2. The research program of the student will be finalized after mutual consultation between the parties.
 - c. Student pursuing short term research at Sai Biosystems for B.Sc/M.Sc. dissertation/ thesis work will be required to pay decided fees for maximum of six months before commencement of research work. The amount payable will be subject to revision each academic year.
 - d. Lecturer of the party2 of relevant discipline will be identified as Guide/Supervisor and will coordinate the student program at the party2 institute and will be responsible to communicate research to the RTM University.
 - e. The Guide/Supervisor so identified will act as Liaison officer between the institute and the University/ Institute.



- f. The period of work and number of students per discipline shall be decided mutually between the sponsoring institute and the Host institute.
- h. By virtue of being Guide/Supervisor the Lecturer of the party2 will be the member of the advisory committee of the student and all the necessary formalities conferring the status should be completed by the university before the commencement of dissertation/ project/Thesis work.
- i. The Director of the party1 and Director of party2 will settle any differences/ policy issue arising out of the implementation of this agreement after mutual consultation. The decision will be final.
- j. In the Publications arising out of this program authorship must be given to Institute scientist/Lecturer and Students (either as first or second author).
- k. The Intellectual property of the work carried out at Sai Biosystems will be rest with the Institute.

2.0 Effective Date, Duration, Termination of the Agreement

- 2.1.1 The agreement shall be effective from the (date of signing\specify events) and shall be recurring in force for five years from said date.
- 2.1.2 During the tenure of the agreement parties hereto can terminate the agreement either for breach of any of the terms and conditions of this agreement or otherwise by giving a (three month) notice in writing to the defaulting party, failure of either party to terminate the agreement on account of breach or default by other shall not constitute a waiver of that party is right to terminate this agreement.
- 2.1.3 In the event of termination of agreement vide provision 2.1.2 the right and the obligations of the party hereto shall be settled by mutual discussion.



- 2.1.4 The agreement arrived at between the parties here to for utilization of intellectual property shall survive the termination of agreement.

3.0 Notices

- 3.1.1 All notices and other communication required to be served on the sponsoring party under the terms of this agreement shall be consider to be serve if the same shall have been delivered to or left with or posted by registered mail to the sponsoring party at its last known address. Similarly, any notice to be given to the council shall be considered as duly served if the same shall have been delivered to left with or posted by registered mail to the council at its registered address.

4.0 Amendment of the Agreement

- 4.1.1. No amendment of modification of this agreement shall be made unless the same is made in writing by both the parties and their authorized representatives and specifically stating the same to be an amendment of this agreement. The modification/ changes shall be effective from the date on which they are made/executed, unless otherwise agreed to.

5.0 Assignment of Agreement

- 5.1.1. The right and / or Liabilities arising to any party to this agreement shall not be assigned except with the written consent of the party and subject to such terms and conditions as may be mutually agreed upon.

6.0 Arbitration

- 6.1.1. In the event of any dispute or differences between the parties in arising out of or in connection with this agreement. Such dispute or Differences shall be referred to the sole arbitration of the person nominated by both the parties. The award of the Arbitrator shall be final and binding on both the parties. Existing law on arbitration matter shall govern arbitration proceedings.



In accordance with the revised Guidelines for the students to conduct research for their degree programmes as trainees at ICAR Institutes, as approved by the Governing Body of ICAR Society in its 230th Meeting held on 12th March, 2014, please find enclosed herewith the draft umbrella Memorandum of Understanding (MoU) to be executed between ICAR Institutes and Universities/DUs for facilitating students' training/postgraduate research work, for information and necessary action with immediate effect.

This Memorandum of Understanding (hereinafter referred to as MoU) is made on this March 22 day of the month of March in the year 2016 by and between the **ICAR- Central Institute of Cotton Research ,Nagpur** having its Head Office at Nagpur [hereinafter called [First party], a constituent Research Institution of the Indian Council of Agricultural Research, Krishi Bhavan, New Delhi-110 001 on the ONE PART and the **Kamla Nehru Mahavidyalaya, Nagpur** State Government funded Private Institution having its headquarters at Nagpur [Second party] on the OTHER PART (who for the purpose of this MoU are hereinafter collectively referred to as the parties).

The parties, having discussed fields of common research interests and allied activities between the two institutions, have decided to enter into long-term collaboration for promotion of students' training and quality postgraduate research in cutting edge areas in accordance with the provisions contained in the Guidelines issued vide Letter No. 2-8/2012-HRD dated 11th December, 2012 or as revised from time to time.

WHEREAS the "First Party" is involved in the studies on Cotton research such as Biotechnology, Molecular Biology, Biochemistry, Chemistry, Entomology, Microbiology, Botany (Genetics and plant breeding, seed technology, plant physiology), Plant pathology, Agri extension, economics and Agriculture engineering.

AND WHEREAS the "Second Party", established vide F. No 1277/122166/82 dated June 1983 by Govt. of India/Govt. of Maharashtra State (Amar Sewa Mandal's Kamla Nehru Mahavidyalaya) vide Act No. 1956 of Section 2F and 12B and recognized by University Grants Commission] at its Department of Science, Arts and Commerce is involved in education of degree M.Sc. in Biotechnology, Chemistry, Microbiology, Biochemistry, Botany, Zoology, Environmental Science, Electronics and Physics.

AND WHEREAS it has been considered expedient to agree in writing to participate jointly in the projects requiring expertise and logistics from both the parties.

Article 1. Scope

- 1.1 The Second party will recognize the First party as an Institute for conducting research related to the thesis requirement of the research students for
(Name of the degree programme). The Second party will recognize Scientists of the ICAR Institute as recommended by its Director in accordance with the University rules and regulations for guiding students working for the said degree.
- 1.2 Operational details of research effort and collaboration will be made in common research programmes and/or projects restricted to specific mandated domain within the approved disciplines/divisions. The objective(s) for research work for a student coming from a Second party outside NARS should be exclusively different as far as possible.
- 1.3 Research instrumentation facility and library facilities available with the First party and the Second party will be made available to the faculty and research scholars. However, the costs of specific consumables will be borne by the respective organizations.
- 1.4 There shall be an exchange of students for academic, research and training purposes. Accommodation in the Hostel shall be arranged, wherever possible, as per extant rates. The duration of exchange visits will be determined by mutual consent between both the parties.

Article 2. Management

- 2.1 Director of the First party and the Vice-Chancellor/Head of the Institution of the Second party will be responsible to work out operational details of co-operation between the two organizations and ensure proper and effective implementation of this MoU.
- 2.2 The Advisory Committee will meet at least once in a year alternatively in the institutions of the First party and the Second party to review the activities. This meeting shall include presentation on the academic and research activities, which should be open to the students, faculty and scientists.

Article 3. Exchange of Information

- 3.1. The term "information" includes scientific or technical data, results and/or methods of investigation, and other information intended to be provided, exchanged, or arising under project descriptions entered into pursuant to this MoU.
- 3.2. The parties support the widest possible dissemination of information. Each party in joint projects shall be given the right to use, disclose, publish or disseminate such information for any and all purposes.

Article 4. General Provisions

- 4.1 It is understood that the First party and the Second party subscribe to the principle of equal opportunity and do not discriminate on the basis of race, sex, age, caste or religion. Both the Institutions shall abide by these principles in the administration of this agreement and neither party shall impose criteria for exchange of scholars or students, which violate principles of non-discrimination.

- 4.2 Both parties understand that all financial agreements will have to be negotiated separately and will depend on the availability of funds.
- 4.3 Both parties acknowledge that exchange of students from one party to the other shall be subject to the availability of funds and shall comply with the regulations and policies of the First party and the Second party.
- 4.4 Any research publications arising will be jointly published in accordance with the provisions laid out in Item 3.2.1C of the Guidelines for the students to conduct research for their degree programme as trainees at ICAR institutions as notified *vide* Letter No. 2-8/2012-HRD dated 11th December, 2012 or revised guidelines, if any, as may be issued from time to time.
- 4.5 A copy of the thesis/dissertation will be submitted to the First Party after the award of the degree by the Second party.
- 4.6 All questions related to this MoU arising during its term will be settled by the parties by mutual agreement. Disagreements at the operating level shall be forwarded to respective higher officials for appropriate resolution failing which an arbitrator of mutual acceptance may be identified for the settlement of dispute, if any.
- 4.7 All questions not foreseen related to this MoU will be handled by the parties by mutual agreement.
- 4.8 Nothing in this MoU is intended to affect other cooperation or collaborations between the parties.

Article 5. Intellectual Property Rights

- 5.1 The Second party will be expected to ensure protection of the Intellectual Property Rights generated or likely to be generated during the student's research work. The ICAR as the first applicant (for its institute) and the Second party shall be the joint applicants for IPRs and the students and involved scientific staff shall be included as the inventor/breeder/author. The 'ICAR Guidelines for Intellectual Property Management and Technology Transfer/Commercialization' as amended from time to time shall be the reference for exploitation of the generated intellectual property, whose management and benefits sharing shall be mutually decided in each case.

Article 6. Admission and Fees

- 6.1 All those who wish to register as trainees or for Master/Doctoral programme under this MoU must apply for admission at the Second party. The allocation of Major Guide/Advisor would be finalized before the registration and will be governed by the provisions laid out in Items 3.2.1A and 3.2.2A of the Guidelines for the students to conduct research for their degree programmes as trainees at ICAR institutions as notified *vide* Letter No. 2-8/2012-HRD dated 11th December, 2012 or revised Guidelines, if any, as may be issued from time to time, for the students from within NARS and outside NARS, respectively.
- 6.2 Admission of the students and the award of degrees for different programmes will be the responsibility of the Second party as per the rules and regulations.
- 6.3 Allotment of the students at the First party will be done by the approval of Director of the First party and Vice-Chancellor/Head of the Institution of the Second party.
- 6.4 The First party would have the right to screen the student's eligibility for admission based on their academic period.

- 6.5 The PME Cell of the First party in consultation with the representative of the Second party shall decide the location and sharing quantum of research work.
- 6.6 The number of student(s) at any particular time will be subjected to the availability of research facilities and scientists' time to guide thesis research at the First party institution.
- 6.7 Any student(s) admitted to the First party for training/postgraduate research, if found violating the rules and regulations laid down by the First party or indulge in such activities that amount to tarnishing the image of the Institute, or cause damage to the property, the registration of such student(s) would be summarily terminated. The Second party will not complete the formalities of issuing the certificates to such students until they compensate the losses to the First party.
- 6.8 Fees will be charged from the students by the First party as per Guidelines for the students to conduct research for their degree programmes as trainees at ICAR

Institutions vide Letter No. 2-8/2012-HRD dated 11th December, 2012 or revised Guidelines, if any, as may be issued from time to time. No fee may be charged by the First party from the students registered with AU/DU within NARS. However a student registered with a Second party, outside NARS, will deposit fee of Rs. 10,000/- for training duration of 3 months (not leading to a degree/dissertation) and Rs. 30,000/- per semester (six months) for training, research, dissertation exceeding three months. Any change in fee structure by ICAR will be applicable from the date of revision and shall be charged by the First party.

Article 7. Entry into effect, modification and termination

- 7.1. This MoU shall become effective on the date it is signed by the parties and shall be valid for three years extendable up to five years. Both parties shall review the status of the MoU at the end of each three/five year period to determine any modification, whenever necessary. The period of validity of this MoU may be extended by mutual consent up to five years. This MoU may be amended by mutual written agreement and may be terminated at any time by either party upon written notification signed by the competent authority of the party initiating termination. Such notification must be given to the other party at least six months in advance from the effective date of termination.
- 7.2. All joint activities not completed at the expiration or termination of the MoU may be continued until their completion under the terms of this MoU.
- 7.3. No amendment or modification of the MoU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be amendment of the MoU. The modifications/changes shall become part of the MoU and shall be effective from the date on which they are made/executed, unless otherwise agreed to.

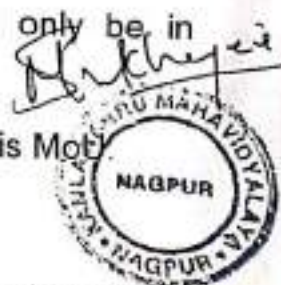
(a) Terms and conditions

1. Objectives

This MOU shall remain valid for a period of two years from the date of signing unless renewed.



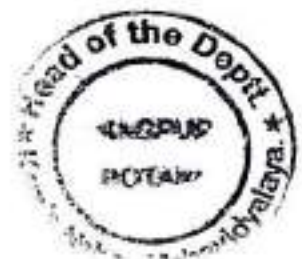

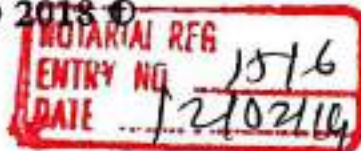

CL. 1 THE MOU

expression shall where the context so admit include its successors and permitted assigns) of the other part.

CL. 2 PREAMBLE

CL.2.1. WHEREAS the PARTY is desirous of collaborating with DBKNM of the one part of research work related with Cow urine, cow dung and other Panchagavya Ayurveda products, Bio-fertilizers, Bio-pesticides and the research area of mutual interest. Now therefore here to agree as follows

CL.3 SCOPE OF THE MOU

CL.3.1. The agreement details the terms and conditions, financial arrangements, Modalities of collaboration, intellectual property rights, responsibilities and obligations of the PARTY and DBKNM, pertaining to the collaborative research and certain short-term courses.

CL.4. FINANCIAL ARRANGEMENTS

CL.4.1. Both the parties shall share the inputs on mutually agreed basis for the research work in the areas of mutual interest.

CL.5. MODALITIES OF COLLABORATION

CL.5.1. There will be joint Monitoring Group for the project. The Monitoring Group shall consist of three or four number of persons each from DBKNM and the PARTY. The Monitoring Group will identify the work to be done by the said college and the party, the targets/milestones and criteria for completion of the project.

CL.5.2. Students of the college will be allowed to visit Go- Vigyan Anusandhan Kendra.

CL.6. RESULT OF THE PROJECT

CL.6.1. The parties shall consult each other for any publication in respect of the projects. These publications (Papers, reports, etc.) shall be in the names of research workers, where in it will be duly acknowledged that the work has been carried out under the collaborative programme between the parties, the PARTY will have no claim over the patents, publication related to the projects completed by the college not in collaboration and vice-versa.

CL.7. FORCE MAJEURE

CL.7.1 Neither party shall be responsible for the non-fulfilment of their respective obligations under this agreement due to the exigency of one or more of the force majeure events such as but not limited to strike, lockouts, epidemics, riots, civil war, commotion and natural calamities like flood, earthquakes provided on the occurrence and cessation of any such events, the party affected thereby shall give a notice in writing to the other party within one month of such occurrence or cessation. If the force-majeure conditions continue beyond six months, the parties shall then mutually decide about the future course of action.

CL.8. EFFECTIVE DATE, DURATION, TERMINATIONS OF THE AGREEMENT.

CL.8.1. The agreement shall be effective from the date of signing and shall remain in force for a period of 60 months from the said date.

CL.8.2. The agreement shall terminate on the expiry of the period, as in clause 8.1 unless extended by both the parties.

CL.8.3. During the tenure of the agreement, parties hereto can terminate the agreement either for breach of any of the terms and condition of this agreement or otherwise by giving a one-month notice in writing to the defaulting party. Failure of either party to terminate the agreement on account of breach or default by the other shall not constitute waiver of the party's right to terminate this agreement.

CL.9. AMENDMENT OF THE AGREEMENT

CL.9.1. No amendment or modification of this agreement shall be valid unless the same is made in writing by both the parties or this authorized representative and specifically stating the same to be an amendment of this agreement. The modification / changes shall be effective from the date on which they are made / executed, unless otherwise agreed to.

CL. 10. ASSIGNMENT OF THE AGREEMENT

CL.10.1. The right of the liabilities arising to any party to this agreement shall not be assigned except with written consent of other party and subject to such terms and conditions as may be mutually agreed upon.

CL.11. ARBITRATION

CL.11.1. Except as herein before provided, any dispute arising out of this agreement, the same shall be referred to the arbitration of arbitrators, one to be appointed by each party to the dispute, and in case of difference of opinion between them to an committee appointed by the said two arbitrators before entering on the reference, and decision of such arbitrators or umpire and the arbitration proceedings shall take place under the Indian Arbitration Act,1996.

1. Objectives

2. Exchange /Deputation of Staff

To exchange Teachers, PG Scholars, Ph.D.Scholars, Scientists/technical personnel on full-time/part-time basis for a limited period not exceeding one year at a time for the purpose of implementation of joint tasks within the areas of co-operation. The expenses towards research on honorarium, consumables, travel and contingencies shall be borne by each party on their own as specified in the joint research programme.

- Consider the new R & D proposals for joint collaboration and implementation on case to case basis including Intellectual Property Right (IPR) and financial arrangements.

For the first year 2020, there are 2 programs i.e. Certificate Course in Operation Theatre Technician and Certificate Course in Dialysis Technician. For the subsequent years, new courses proposed are to be mutually agreed between KNM and TSPL.
- b. Manage the entire academia delivery in terms of theory sessions, practical sessions [industry connect], examination conduct, assessment, and certification of students.
- c. In the current pandemic conditions, all theory sessions will be conducted through online, virtual classroom mode. Going forward, while this method will persist however, a few sessions will be dealt in classroom mode on case to case basis.
- d. Create mandatory internship opportunity for all students to give them the real industry work exposure as a standard work of this program.
- e. Bring in external certification agency like Maharashtra State Board for Vocational Education for program accreditation.
- f. Create placement opportunity for deserving candidates after successful completion of the program.

General terms and conditions

1. Fee structure will be reviewed every year with mutual discussions between KNM and TSPL.
2. No course material, data, research findings or any such information of confidential nature shared between the parties as part of activities mentioned under this MoU will be used or shared by either parties for commercial use without formal written consent and due acknowledgement of the other party concerned (i.e. two parties as per this MoU are KNM and TSPL).
3. It is hereby made clear that this is a broad expression of intent to compliment the efforts of both the parties wherever opportunity exists, and the intention of the parties is not to create binding agreement between the two parties and no party shall have right to file any claims against the other party. The parties understand that this MoU gives neither any right to file any claims against other party, nor it creates a partnership, joint collaboration or any other entity.





4. The existence, nature, terms and conditions of this Agreement are strictly confidential and shall not disparage, or disclose any information, in any manner or form, directly or indirectly, to any person or entity, under any circumstances about
- a. The beneficiary/student/any other related information
 - b. Schemes related confidential data.
5. Both parties can terminate/ modify this agreement whenever they wish with three months' notice ensuring KNM-iTransform Paramedic Center scope committed to the students is not jeopardized.
