(First Party and Second Party are hereinafter jointly referred to as the "Parties" and individually as "Party").

WHEREAS

First Party is one of the most reputed colleges in Nagpur named

Kamla Nehru College Nagpur

The First Party & Second Party believe that collaboration and cooperation between themselves will promote a more effective use of each of their resources and provide each of them with enhanced opportunities.

A) The Parties intent to cooperate and focus their efforts on cooperation within the area of Skill Based Training, Education and Research.

B) Both Parties, being legal entities in themselves, desire to sign this MOU for advancing their mutual interest.

C) GGC'S PRACTICAL TRAINING ACADEMY PRIVATE LIMITED, the Second Party is engaged in the Business of financial consultancy and training and skill development and **GGC'S PRACTICAL TRAINING ACADEMY PRIVATE LIMITED**, the Second Party is promoted by the **Promoter** named **CA Sumit Tajpuriya, GGC'S PRACTICAL TRAINING ACADEMY PRIVATE LIMITED**.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the college. The Parties shall keep each other informed of potential opportunities and shall share the related information that may be relevant to secure additional opportunities for one another.

1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party, providing significant inputs to them in developing suitable teaching/training systems, keeping in mind the needs of the industry.

1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall co-operate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds, and documents

(the "Definitive Documents") as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2: SCOPE OF THE MOU ALONG WITH TERMS & CONDITIONS

2.1 The budding finance graduates from the Institutions could play a key role by acting as skilled finance professionals of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student and youth community to enhance their skills and knowledge and employability.

2.2 **Training Methodology:** Second Party would provide virtual training to students of First Party.

2.3 **Hands on Training:** The practical training and exposure provided to selected students through internship opportunities will build confidence and prepare the students to have a smooth transition from academic to working career.

2.4 **Internships and Placements of Students:** Second Party will actively engage to help the delivery of the Internship and Placement of **selected** Students of the First Party into internships/jobs. Internships would be given to only those candidates who would be clearing the Eligibility Test (ET) which would be conducted post 45 days of training. For clearing the ET, a minimum of 60% score needs to be secured by the enrolled students.

2.5 **Skill Development Programs** – Second Party to train the students of First Party on the emerging cloud-based technologies in order to bridge the skill gap and make them industry ready.

2.6 Both Parties to obtain all internal approvals, consents, permissions, and licences of whatsoever nature required for offering the Programs on the terms specified herein.

2.7 It is agreed between the parties that Second Party would provide virtual training on 8 modules as listed on the website of second party for 45 days.

2.8 Students of First party should have Android mobile phones on which mobile application of Second Party would be downloaded from the app store, and once all formalities are completed, then a unique user ID and password would be created for each enrolled student.

2.9 Schedule to watch the training sessions would be shared on day one, and on WhatsApp, daily follow up would be done by team of Second Party to make sure that students are watching the lectures as per the schedule. A report of

students who are not sincere would be shared to the First Party by Second Party so that necessary follow ups can be done by the First Party.

2.10 A certificate would also be issued by Second Party to all the candidates of First Party based on the scores of the Eligibility Test (ET).

2.11 It is clearly agreed between First Party and Second Party that **Free Training on Course (1) i.e., Financial Management** would be provided by Second Party to First 100 **enrolled Commerce students** of First Party for a period of 45 days on 8 topics listed along with the attached brochure, thereafter each enrolled student needs to pay the required fees of Rs. 500.

It is clearly agreed between First Party and Second Party that **Training on Course (1) i.e., Financial Management** would be provided by Second Party to the **enrolled Finance Students** for the fees of Rs.1,000 per student for the period of 45 days on 8 topics listed along with the attached brochure.

2.12 It is clearly agreed between First Party and Second Party that Second Party will be conducting the Second Course, Financial Literacy. This course is not Free and any student opting for the Financial Literacy Course needs to pay the required fees of Rs. 500 per student. Since in the Financial Literacy Course of Second Party, the intent of Second Party is just to inculcate the sense of "How to Manage the earned money" and no employment opportunities can be provided in the second course, hence the same would be chargeable for anyone opting for the same. Course 2 is completely optional for students and there is no compulsion to go through Course 2 along with Course 1.

2.13 It is clearly agreed between the First Party and Second Party that First Party will provide the Second Party with the candidates as and when available and necessary for marketing, coordinating and managing the events organised by the Second Party as per the availability of the candidates.

CLAUSE 3: INTELLECTUAL PROPERTY

3.1 Nothing contained in this MOU shall, by express grant, implication, /estoppels or otherwise, create in either Party any right, title, interest, or licence in or to the intellectual property (including but not limited to knowhow, inventions, patents, copy rights and designs) of the other Party.

CLAUSE 4: VALIDITY

4.1 This Agreement will be valid till **1 academic year, 2023-24** from the date of signing until it is expressly terminated by either Party on mutually agreed terms, during which **GGC'S PRACTICAL TRAINING ACADEMY PRIVATE LIMITED** the Second Party, will take effective steps for implementation of this MOU.

4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

CLAUSE 5: RELATIONSHIP BETWEEN THE PARTIES







MEMORANDUM
OF

(PAN: AASCS8515R and CIN: U72200MH2013PTC241118), a private limited company incorporated under the Companies Act, 1956, engaged in providing online educational courses to students, having its registered office at 1st and 2nd Floor, Zion Building, Plot no. 273, Sector No. 10, Kharghar, Navi Mumbai, Raigarh, Maharashtra – 410210 (hereinafter referred to as "Skill Academy ", which expression shall unless repugnant to the context or meaning thereto shall mean and include its successors and permitted assigns) represented herein by its Director, Mr. Ashutosh Kumar, duly authorized by its board of directors vide resolution dated 16th November 2019.

"Parties

WHEREAS

A. Skill Academy will provide its services under **Skill Academy Campus Program** for use by KNM in respect of "End Users" (all students who are presently enrolled in any program with the institution), in accordance with the terms and conditions set out herein.

B. Pursuant to the foregoing, the Parties have agreed to enter into this MoU to set forth the terms and conditions of their arrangement in the following sections.

As a part of this MoU, both the parties have identified and hereto agree to the following responsibilities respectively:

1. RESPONSIBILITIES

1.1 Responsibilities of Skill Academy

A. Skill Academy with the help of KNM shall get all the willing students of KNM to register in the Skill Academy Campus Program with email ID & contact number to avail the services & benefits.

B. There will be no financial implications involved between Skill Academy and KNM

IN CONSIDERATION OF THEIR RESPECTIVE OBLIGATIONS, COVENANTS, RIGHTS, AND WARRANTIES AND REPRESENTATIONS HEREIN CONTAINED, IT IS AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. Purpose:

The purpose of this MoU is to provide a framework of cooperation and to facilitate collaboration between the Parties, on a non-exclusive basis, in areas of mutual interest for the successful achievement of the Program.

Scope, Activities, and Implementation Arrangements:

The Parties mutually agree to collaborate in the following areas, encompassing but not limited to:

1. **Drafting the Module Training Program for the Train the Trainers (ToT) Program:**
Develop a comprehensive training program outlining key modules for the Train the Trainers initiative.
2. **Conducting a Self-Assessment of the Institute/Centre of Excellence:**
Perform a thorough self-assessment of the Institute/Centre of Excellence, including SWOT analysis.
Identify gaps and establish a 12-month roadmap for improvement.
3. **Implementing Module 1 - Frameworking the Incubator Ecosystem:**
Execute Module 1 focusing on framing the incubator ecosystem, ensuring a solid foundation.
4. **Implementing Module 2 - Incubation Cycle and Its Tools & Templates:**
Implement Module 2 covering topics like the Incubator Business Model Canvas, mentoring, fundraising support for startups, and monitoring & evaluation.
5. **Implementing Module 3 - Operating an Incubator:**
Execute Module 3, addressing aspects such as planning and reviewing operations, building an incubator culture, and developing a final Incubator Roadmap.
6. **Implementing Module 4 - Incubator Governance:**
Incorporate incubator visits and organize a 3-day physical boot camp in Baramati as part of Module 4. Boarding and lodging costs will be borne by the respective institutions of the trainees.
7. **Provide Yearlong Handholding Support:**
Offer continuous guidance, troubleshooting, and assistance to ensure the seamless operation of the "Train the Trainers" initiative.
8. **Conduct Monthly Follow-Up Meetings:**
Hold monthly follow-up meetings to review progress, address concerns, and ensure alignment with program objectives.
9. **Provide Basic Documentation Support:**
Supply essential tools and templates required for the effective functioning of the Incubation Centre.
10. **Conduct Refresher Course Annually:**
Organize an annual refresher course with advanced modules tailored to the evolving needs of the Centre of Excellences.
11. **Educate Team Members for Proposal Drafting:**
Provide training to team members of the Centre of Excellences for drafting proposals, catering to various Government Agencies.



12. Empower Trainers for CSR Donor Pitches:

Equip trainers with the knowledge and skills necessary for effectively pitching to small CSR donors.

2. Communication and exchange of information:

The Parties shall, on a regular basis, keep each other informed of and consult on matters of common interests, which in their opinion are likely to further the collaborative efforts of the parties as documented in this MoU.

3. Use of Logos

A Party shall obtain the express written consent of the other Party before using the Logo/Symbol/Trademark of each other.

4. Effective date, duration, and termination of the MoU:

The MoU shall be effective from the date of its execution and shall remain in force for a period of Five years. The parties may extend the term in writing. The MoU may be terminated by either Party by giving a written notice of 30 days to the other party, without assigning any reason thereof.

5. Confidentiality:

- i. Confidential Information includes all communication of information/ideas disclosed/derived in documentary or tangible form between the Parties, including oral, written, and machine-readable forms. In the case of such information disclosed orally or visually, the Disclosing Party shall confirm in writing the fact and general nature of each disclosure within (30) days after it is made. The Party disclosing the Confidential Information shall be referred to as the Disclosing Party. The Party receiving the Confidential Information shall be referred to as the Receiving Party.

6. Represents and Warranties

Both the Parties hereby represent and warrant that:

- a) It is a duly organized entity, validly existing and fully compliant with all applicable law.
- b) It has all corporate, statutory, and other authorizations, licenses, and consents necessary to legally execute and perform its obligations under the MoU and shall continue to have all such



authorizations, licenses and consents during the entire tenure of the MoU or any extension thereof if any.

- c) It has full rights, title, and interests in the outlets or such rights, approvals, and permissions as are necessary to enable it to use the outlets for the purpose of its business.
- d) Both the Parties do not guarantee the success of the Program to each other.

7. Force Majeure Clause

Neither Party shall be liable for any failure or delay on its part in performing its obligations under this MoU if such failure or delay is due to Force Majeure conditions (such as riots, lockouts, floods, war, government regulations, Act of God etc.) in whole or in part makes it impossible for the other party to perform its obligations under this MoU.



Any dispute, difference, controversy, or claims ("Disputes") arising between the parties out of or in relation to or in connection with this MoU or the breach, termination, effect, validity, interpretation, or application of this MoU or to their rights, duties or liabilities hereunder, shall be settled by the parties by mutual consultation. If for any reason such Disputes cannot be resolved amicably by the parties, disputes shall be referred to the Arbitral Tribunal consisting of a sole Arbitrator to be appointed mutually by the Parties. Arbitration proceedings shall be conducted in accordance with the provisions of the Arbitration and Conciliation Act, 1996, or any statutory re-enactment of the same and the rules framed hereunder.

9. Notice

Any notice or communication required by this MoU shall be deemed sufficiently given if delivered in person, by certified mail, or by e-mail to the respective addresses.

10. Authorization and Execution

The execution of this MoU does not constitute a formal undertaking and as such it simply intends that each Party shall strive to reach, using commercially reasonable efforts, the goals and objectives stated in this MoU.

10.1 Consultancy Services:



The Knowledge Partner agrees to provide knowledge and expertise for the "Train the Trainers" (ToT) program to enhance the capabilities of the Client's Institute/Centre of Excellence in establishing and sustaining an Incubation and Innovation ecosystem.

10.2 Consultancy Fees:

In consideration for the consultancy services rendered, the Client agrees to pay the Knowledge Partner a consultancy fee of Rs. 15000/- per trainee per year per center participating in the ToT program, with 10% increase in fees every year.

10.3 Payment Terms:

Payment of the consultancy fees shall be made through online/offline payment methods not later than one month from the commencement of the program.

11. Governing Law

This MoU shall be governed by and construed in accordance with the laws of India.

12. Counterparts

This MoU may be signed by originals and executed in any number of counterparts, and each executed counterpart shall be considered to be an original. All executed counterparts taken together shall constitute one MoU.
